Peaking at £250 was a Charolais heifer from Parry, Croesgwyn; £208 for an AA bull from Jones, Pantyrhendy; £198 for a Lim heifer from Jones, Gorlan; £185 for a Hereford bull from Thomas, Cilau Farm; £172 for a Hereford bull from Anthony & Partners, Waun Fawr. The best rearing black and white calves reached £145 from Griffiths, Tredafydd who also sold at £92, £82 and £80; £80 for a Friesian and Holstein Friesian from Anthony & Partners, Waunfawr and Emerald Grove Farms Ltd, Gelliorlas respectively.
